



ITTN+EMIRATES Travel Photographer of the Year 2017

Terms and Conditions

3. The competition will run from 1st June to 31st October 2017 and photos taken since 1st November 2016 are eligible. There is no entry fee. Each person may enter a maximum of five photos per month.

Image files must be a minimum of 300 dpi and a maximum of 5MB.
5. No responsibility can be accepted for lost entries and proof of transmission will not be accepted as proof of receipt.
6. All photos submitted must be the work of the individual submitting them and must not have been published elsewhere or have won a prize in any other photographic competition. It is the responsibility of each entrant to ensure that any images they submit have been taken with the permission of the subject and do not infringe the copyright of any third party or any laws. Entrants must warrant that the photograph they are submitting is their own work.

By making each submission, the entrant agrees to grant, free of charge, worldwide, irrevocable, perpetual copyright of each photo to Belgrave Group Limited, who may feature any or all of the submitted images in any of their publications, their websites, their social media, and/or in any promotional material connected to this competition.
